

Privacy Statement – Turing Technologies AG

General

Turing Technologies respects the privacy of every individual who visits our websites or responds to our interactive advertisements. This Privacy Statement outlines the information Turing Technologies will collect and how we will use that information.

Personally Identifiable Information

When you visit Turing Technologies' website, we will not collect any personally identifiable information about you (such as your name, address, telephone number, billing and shipping information, credit card information or e-mail address) unless you provide it to us voluntarily. If you opt not to provide us with personally identifiable information no material consequences will result, although you may be unable to receive product information through Turing Technologies' website.

Google Analytics

However, the website uses Google Analytics, a web analytics service provided by Google LLC, with registered seat in Mountain View, California (USA). Google Analytics uses Cookies, which are text files saved on the Users' computers, to allow for an analysis on the use of the website. The information generated by such Cookies about the use of the website (including the IP addresses of the Users, which will however be anonymized before saving and, hence, not be assignable to a specific connection) will be transmitted to and saved by Google LLC on servers in the United States.

Use of Personally Identifiable Information

Turing Technologies may store and process your personally identifiable information to better understand your needs and how we may improve our products and services, and we may use your personally identifiable information to contact you (for example, we may - subject to your telling us otherwise - send you marketing or promotional materials or other information, we may respond to your comments or requests for information). We may also enhance or merge personally identifiable information with data obtained from third parties for the same purposes. Turing Technologies will not give or sell your personally identifiable information to any outside organization for the organization's own use without your consent. Your information may be shared with agents or contractors of Turing Technologies in connection with services that these individuals or entities perform for Turing Technologies. These agents or contractors may be based in Switzerland or in any other country. This



means that your personally identifiable information may be transferred to, processed and held in Switzerland or in any other country. These countries may not have similar data protection laws to Switzerland. However, regardless of where we transfer your information to in this way, we will take steps to ensure that your privacy rights continue to be protected in compliance with the data protection legislation in Switzerland as well this Privacy Policy. Individually identifiable information submitted in connection with employment inquiries will be used only in the application process. At times, if you direct comments to us or if you request information from us, we may ask you to indicate to us your country of residence so that we can be assured that the response or information we provide is appropriate for your country of residence.

Security

Turing Technologies is committed to keeping secure the data you provide us and will take reasonable precautions to protect your personally identifiable information from loss, misuse or alteration. Agents or contractors of Turing Technologies who have access to your personally identifiable information in connection with providing services for Turing Technologies are required to keep the information confidential and are not permitted to use this information for any other purpose than to carry out the services they are performing for Turing Technologies.

Children

Turing Technologies has no intention of collecting any personally identifiable information from individuals under thirteen years of age. Where appropriate, Turing Technologies will specifically instruct children not to submit such information on our websites or advertisements. If a child has provided us with personally identifiable information, a parent or guardian of that child may contact us at the e-mail address or address listed at the bottom of this Privacy Statement if they would like this information deleted from our records. We will use reasonable efforts to delete the child's information from our databases.

Non-Personally Identifiable Information Collected Automatically

In some cases, we may collect information about you that is not personally identifiable. Examples of this type of information include the type of internet browser or computer operating system you are using and the domain name of the website from which you linked to our site or advertisement. In addition, when you view one of our websites or advertisements, we may store some information on your computer. This information will be in the form of a "cookie" or similar file and will help us in many ways. For example, cookies allow us to tailor a website or advertisement to better match your interests and preferences. Most internet browsers enable you to erase cookies from your computer



hard drive, block all cookies, or receive a warning before a cookie is stored. Please refer to your browser instructions or help screen to learn more about these functions. Turing Technologies does not collect personally identifiable information automatically, but we may tie information collected automatically to your previously submitted personally identifiable information.
